#### 8/16 District Cllr. and Police reports:

<u>PCSO Vicky Elliot</u> reported that 2 incidents had taken place in Rous Lench – dog incident on the Village Green and tools taken from an outbuilding. Speed checks carried out in the area:

Radford Road 12<sup>th</sup> April – 7 drivers advised of their speed and 4 tickets issued as vehicles travelling over 36mph; 20<sup>th</sup> May 51 vehicles targeted in the time period travelling at an average of 30.2 mph. 8 drivers advised of the speed they were travelling at.

Operation Dolphin is in place at present to try and combat speed in rural villages.

It was asked if speed checks could be carried out further along Radford Road past the Severn Trent Plant. The area would have to be assessed first by the Police.

#### Dist.Cllr. Mr. Wilkinson:

Cllr Mrs Frances Smith was elected as Chairman of the District Council for 2016/17 and Cllr Mrs Liz Eyre as the Vice-Chairman. The Chairman's chosen charity for her year of office is St Richard's Hospice.

In the Queen's Speech it was said that every household is to have a legal right to high-speed broadband. It is expected that an initial minimum speed of at least 10 Mbps will be available to
