DCIIr Rowley reported that the Tibberton New Homes Bonus application, which had been supported by 52 out of the 56 respondents in the recent consultation, had been approved by the Localism and Community Funding Advisory Panel on 2<sup>nd</sup> June and a final decision would be made at the Executive Board meeting on 25<sup>th</sup> July.

## 7.8 Reports by Councillors

- a) Village Hall: Concern was expressed that the Village Hall Committee had not met recently and no reports had been received. It was agreed that the Clerk should be asked to write to the Committee Chair to request a report to be sent to the next Parish Council meeting. The parking of cars at the village hall by non-users is preventing parking by legitimate users was mentioned as a particular problem.
- b) Neighbourhood Watch: 'Nottingham Knockers' had again been visiting properties in the area and residents had felt intimidated by their behaviour. Reporting this to the police had not produced a satisfactory response. SP reported on a number of thefts from farm buildings. West Mercia Police have launched 'operation snap' whereby members of the public observing motoring offences are encouraged to record the offences on their mobile phones and send their pictures to www.westmercia.police.uk/operationsnap.
- c) Community Speed Watch: MR reported that the group of volunteers were active and continuing to monitor vehicle speeds in the village. The two most recent sessions had recorded 9 and 7 cars exceeding the speed limit.
- d) Tibberton Community Land Trust: MR updated Members re progress on the allocation of lettings at the Hawthorn Rise development 8 out of the 10 successful applicants a connection with Tibberton, 1 was from Crowle and 1 property remained to be let.
