# Draft Minutes of the meeting of Dodford with Grafton Parish Council held on Thursday 21 October 2010 in Dodford Village Hall at 7.30pm

#### 1. Apologies for absence

Apologies were received from Cllr Lynne Griffin and accepted.

#### 2. Declarations of interest

None declared.

The meeting was adjourned for members of the public to raise matters of interest/items for the next agenda:

- i. Hedge in Priory Road opposite Village Hall is now being worked on.
- ii. Police are surveying scrap metal merchants.
- iii. Worcestershire County Council (WCC) is currently photographing historical buildings in the village.
- iv. PACT meeting in Bournheath still problems with vehicles going to and from Bumble Hole Foods.
- v. New Police Sergeant Laura Wright.
- vi. Proposed creation of an elected Police Commissioner in 2012. To be added as an agenda item for November meeting.

#### 3. Minutes of the Parish Council meeting on 9 September 2010

Approval of the Minutes was proposed by Cllr Harper and seconded by Cllr Rea after which they were signed by the Council Chairman as being a true record.

#### 4. Reports
