**District Councillor:** Bentley have been given leave to appeal for judicial review over Foxlydiate planning application by High Court Judge, which is very unusual.

**County Councillor:** The Chairman to speak to Cllr Taylor re Lickey and Blackwell path and Wharf Lane/Stoney Lane junction visibility issues as nothing has been done about it. Write to footpath warden re closing of footpath over Lickey and Blackwell as we thought that it had been extinguished years ago. We were promised footpath years ago. **Footpath Warden:** the following report was sent by the Footpath Warden:

1. The three open issues from last year mentioned in the last meeting minutes are still open and "in progress" by Worcester.

2 The issue raised by Cllr Whittaker about a blockage on path TC520, Alvechurch Station to Grange Lane has been cleared.

3. The issue raised about footpath TC536 up from the canal to the church car park, about the collapsed "siding" of the gravel, has been fixed - by Cllr Ryan.

4. We had a complaint registered on the Worcestershire Council website about footpath TC510 (from Hewell lane northwards along the side of the railway), for "vegetation".

The real story is that this quite well used path should angle across the middle of the field - and the landowner has put up a sign on it saying "No Trespassing - We're tired of hiding the bodies"...! However he has also mowed a metre wide path around the edge of the field to encourage walkers to go around the edge... I have strimmed the stiles at both ends and I will mark this job as closed and see what happens.

Tree Warden: not putting trees in until ground is more moist,

**Conservation Officer:** Plymouth House is nearly completed and some units have been let. **Community Hall Representative:** none

**Charities Representative**: Cllr Pengelly is the new Chairman, predecessor has sorted out the finances. Treasurer has also left. Cllr Wheeler-Vine and Cllr Pengelly have something to sort out beforehand. Not sure if there will be a new Vicar at the Church yet.

# PLANNING MATTERS:

Applications for consideration: 22/00559/CPE - Arrowfields Barn, Grange Lane, Alvechurch, Birmingham - Use of land as a domestic garden in association with the residential occupation of Arrowfields Barn, Grange Lane, Alvechurch, together with the retention of two outbuildings as ancillary permitted development within the curtilage of that property - closing date for comments 16<sup>th</sup> July 2022. Tutnall and Cobley PC accept that the curtilege of the Arrowfield Barn has not changed since the business was converted to a dwelling in 1986. Councillors saw no reason to not grant the certificate of lawfulness.

22/00822/FUL - Border Fencing, Lower House Farm, Stoney Lane, Alvechurch - Redevelopment of former fencing and timber building construction business for residential development - closing date for comments 25<sup>th</sup> July 2022. The applicants had not been able to attend the meeting but had emailed the Parish Clerk to provide some background information to the Parish Council regarding the history of Border Fencing and the challenges the business faced and the reasons for proposing the residential development. The Parish Council supported the application and were pleased to see some of the existing buildings were being retained and converted to retain the character of the site

**22/00931/CUPRIO** - Cobley Hill Farm, Cobley Hill, Alvechurch, Birmingham -Change of use of two agricultural buildings (Barns A and B) to five dwelling houses closing date for comments 4<sup>th</sup> August 2022. The Parish Council discussed the proposed development and agreed to support the application.
