- WINDPUMP: Although not present at the meeting, Cllr Cooper had advised that he had not received quotes back from Engineers regarding the wind pump.
- **BROCKHILL LANE:** Cllr Whittaker is enquiring at the Council about this. The Chairman stated that there are some digital cameras, which could be purchased to record issues, if necessary.
- 13 LENGTHSMAN SCHEME: The Lengthsman to be asked to cut back around signs on Alcester road, stating community hall, away from sign, so that it can be viewed from traffic at either end. Also to trim around signs around Agmore Lane and Wheely Road by golf course. Lengthsman also to be asked to contact Cllr Denyer regarding installation of signposts.
