12/10/09	Chairman's Report – Cllr Karen May				
	Bournheath Chapel may need substantial funding and support to deal with damp-related problems. KM will forward the weekly Funding Lists from WCC. Members are aware of this building being of particular interest to the community.				

Severn-Trent were fined £25,000 + costs on 04/10/2012 for the pollution of Elmbridge Brook in February 2011. KM and GL are to meet with R Rogers of Severn Trent on 07/11/2012; would like a guarantee of regular checks. Also to meet with County Councillor and officers regarding the flooding situation and possible solutions.

WCC planning officers would be asked for information regarding the licence at Veolia site and any volume restrictions. Residents would be advised to contact Severn Trent immediately if they smell or suspect sewage is being discharged into the culverts/storm drains.

KM and SH had been called by a resident to view a neighbour's fence that had been painted pink, but as this was a neighbour dispute and was already included on the planning enforcement list, it was not appropriate for the parish council to intervene.

KM had received a 'request for information' from a parishioner which was replied to. GL had received the same request but as it related to information that had been presented to the meeting verbally there was no information to provide.

KM had received requests to meet from a relative of a member of Bournheath Village Hall management committee and had replied asking him to attend the parish council meeting. Members agreed with this course of action in this case and asked the Clerk to respond to the relative outlining all future communication on this specific matter should be via the Clerk.

## 12/10/10 Clerk's Progress Reports

- a) <u>Flower troughs</u> : work is in progress.
- b) <u>Christmas tree lights</u> : to be installed at appropriate time.
- c) Pinches Quarry: the road seems to be clear of mud at the moment.
- d) <u>Catshill Library review</u>: feedback had been positive and the favoured proposal, which is to relocate to Catshill Middle School, will be put to WCC cabinet in due course. It was noted there is also a review of the Bromsgrove library with a view to relocation on Stourbridge Road.
- e) <u>Speed Awareness Signs</u>: WCC's Highways Liaison Officer, Richard Clewer, had confirmed the appropriateness of two sites at (1) Rocky Lane (attached to a street lamp) and (2) Dordale Road, the latter requiring the installation of a new crossroads warning sign and liaison with Belbroughton Parish Council and Woodvale Division member.
  It was agreed to purchase a Vehicle Activated Sign from WCC which would be installed by the Lengthsman and moved around between the two sites.
- f) <u>Dog-waste bag dispensers</u>: Bromsgrove DC had agreed to the Parish Council's offer to replace the dispensers that will accommodate the new size bags.
- g) Revision of Standing Orders and h) Bulk oil purchase : items carried forward.
- i) <u>Lengthsman's work schedule</u> : To include attention to hedges Parish Hill, Fairfield Road and drain cover on corner of Yarnold Lane/Doctors Hill

#### 12/10/14 General Power of Competence

The General Power of Competence, a power of first resort, gives local authorities including eligible local councils, the power to do anything that individuals generally may do as long as no other laws are broken. Members were satisfied that the two elements of the eligibility criteria were met in that a) six of the seven members had been elected at the last election (a minimum of two-thirds is required) and b) the clerk holds the appropriate sector-specific qualification (Cert HE in Local Policy and CiLCA 2012, s7).

It was agreed by virtue of the Localism Act 2011 s1(1) to adopt the General Power of Competence.
