**Members agreed to co-opt** Carolyn Marshall to fill the casual vacancy; Cllr Marshall was welcomed to the table and signed the Acceptance of Office.

# 13/09/05 Other Reports

1) Parish Path Warden Report – June Maw was unable to attend this meeting but had provided a report that related to: -

3 new signage posts have been ordered for Badgers Bank (JM would like installation assistance) Village resident Mr Robert Rutter has been providing practical help;

Wildmoor paths are to be cleared;

Footpath no. 509 between Doctors Hill and Dodford Road has been checked.

**Members agreed** to write a letter of thanks to Mr Rutter and believed a token of appreciation would be in order at the appropriate time.

2) Neighbourhood Watch – Bryan Hewett.

NW matters locally appear to be quiet. Cllr Drew reported an attempted break-in in Fairfield Road.

# 13/09/08 Approval of Previous Minutes

The minutes of the parish council meeting held 31/07/2013 were approved and signed.

## 13/09/09 Chairman's Report – Cllr K May

Cllr May had attended District Standards Board meeting recently at which it was stated that everyone involved in setting the precept must make a Declaration of Interest when considering it, whether a parish resident or not.

**Veolia application for IBA plant, Sandy Lane (Belbroughton parish)**. Cllr May had attended the BDC Planning Committee meeting which discussed this application and recommended refusal. Alison Blakeway of Evolution has since advised that the Environment Agency have asked for 6 months' data on air quality which will delay the application being considered by the WCC planning committee.

**Village Hall event – Trade Your Own 26/08/2013.** Cllr May had attended this local event on behalf of the Parish Council. Various questions had been asked relating to planning applications, footpaths and speeding in the village.

**An active speed sign** that is powered by a car battery has been provided by WCC and is currently stored with Cllr May. Cllrs Hall and Drew would visit to assess its potential.

Parish Footpaths, Badgers Bank – Cllr May had visited to effect improvements via footpath warden.

**Road markings at junction of Doctors Hill with Fairfield Road** had not been put back the same way as before the recent re-surfacing. Residents have written to WCC and hope to see improvements.

**M5** motorway vibration effects in Wildmoor Lane; residents have written to Sajid Javid MP who replied with Highways Agency comments, but the data they have provided is not comparable like-for-like. It was agreed to write to the MP to explain the situation more clearly.

**Sheep have been straying onto Doctor's Hill near the culvert** due to inefficient fencing/hedging. The clerk was asked to write to the sheep owner.

**Cutting of grass verge in Doctor's Hill** has been carried out by local farmer and **it was agreed** to send to him a letter of thanks.

**Cutting of grass verge in Rocky Lane** by the Probation Service had been curtailed by local resident who asked for the ants' nest to be left undisturbed and for cutting to take place instead in May 2014. **It was agreed to** make a note in next year's diary.

### 13/09/10 Progress reports from the Clerk:

**Lengthsman update** – concerns were discussed relating to drainage at the 5-ways junction (Yarnold Lane, Dordale Road, Parish Hill, Dodford Road, Doctors Hill) which would be drawn to County Highways' attention.

New bench – this is yet to be installed.

Village Community Centre notice board – no progress.

**Bumble Hole Foods construction traffic** – County Highways have advised that they cannot force traffic to use a specific route even though local roads may be unsuitable for the size of vehicle. BHF are aware of large traffic en route to their site via local roads and have put up signs to mitigate the problem and will speak to the hauliers concerned.

**Purchase of bulbs**; 4 x 25kg sacks of daffodil bulbs have been purchased to be planted in the parish via the Lengthsman and Cllr S Hall.

**Meeting with the Safer Neighbourhoods Inspector, Sharron Cannings** – on Monday 23<sup>rd</sup> September at Catshill Village Hall, via Catshill and North Marlbrook Parish Council.

**Meeting with Highways Agency** - on Thursday 26<sup>th</sup> September at Catshill Village Hall, to hear about the M5 junction 4 improvements.

**Loss of retaining wall, Claypit Lane junction with** Fairfield Road – the crossroads was cleared of mud by HPU and the (Old School House) wall has been rebuilt.

**Flood alleviation** – North Worcestershire Water Management (NWWM) Multi-Agency Flood Plan is expected and will include contact details for the Lengthsman. Concerns were raised at the meeting that the Valley Road culvert pipe diameter is not large enough to cope with flood water in Valley Road. The clerk will ask for an update.

**NWWM** – an anonymous letter had been received by NWWM manager who, unable to respond to the sender sent a response instead to the parish council where it is available

Bromsgrove Area committee meeting of WorcsCALC held 4/9/13 was circulated.

**Billing Authority precept support** – A response had been received from Eric Pickles office, DCLG reiterating the district council, as the billing authority, should have 'worked with parish councils in deciding the level of the grant to pass down'. The letter recommends asking 'the local MP to contact Bromsgrove and ask them to reconsider their decision to ensure the impact of the support schemes is shared across all precepting bodies.'

## 13/09/11 Wildmoor Report - Cllr H Feeney reported:-

**Mill Lane** – the newly widened junction with Wildmoor Lane does not appear to have improved road safety; WCC Highways to be informed.

**Pinches Quarry** – sand and mud covers the road which covers over the potholes and there appears to be no wheel washing. WCC Highways / Planning (Quarries) to be informed.

## 13/09/12 Bournheath Village Community Centre – Report from Cllr K Drew

The new committee continues to establish a better understanding of requirements.

Coming events include a Quiz on 4<sup>th</sup> October; possibly a Christmas Fayre / craft fayre on 7<sup>th</sup> December; AGM Friday 29<sup>th</sup> November at 7.30pm.
