# 99/12 Apologies

The apologies of County Councillor Peter McDonalad and District Councillor Richard Deeming were received and accepted.

# 100/12 Declarations of Interest

The requirement to keep the Register of Interests was noted.

Cllr Charles Hotham declared an interest in agenda items 105/12(a)(iv) and 105/12(b)(i)

No other interests were declared by Parish Council Members.

#### 101/12 Minutes of the last meeting

The minutes of the meeting dated 26 November 2012 were approved and signed by the Chairman.

# 102/12 Chairman's Report

The Chair commented on recent seasonal events in the village highlighting the village lights and the work of local traders in offering a series of late night openings in December.

Councillors thanked the Chair for the volunteer Christmas lunch.

#### **103/12 District Councillors' and County Councillor's question and answer session** District Cllr Stuart Dudley reported on:

- (i) the residential development of Fiery Hill Road commenting that:
  - a greater proportion of affordable housing will be shared ownership;
  - Banner Homes had encountered some land ownership issues with Network Rail;
  - The maintenance of the proposed car park will probably be linked to the residential development.
- (ii) the implications of the 'duty to co-operate' with neighbouring authorities on likely housing numbers within the Bromsgrove District;

Cllr Dudley was asked to check whether the time given to Banner Homes to resolve reserved matters had expired.

Cllr Dudley was asked to confirm that the drainage infrastructure proposed for the residential development of Fiery Hill Road was adequately specified.

#### 104/12 Neighbourhood Plan

The minutes of the Neighbourhood Plan Committee meeting dated 3 December 2012 (Enclosure A) were received.

#### 105/12 Infrastructure

# (a) Planning and Conservation

- (i) The report on planning applications and decisions made by the District Council's Planning Committee (Enclosure B) were received.
  Councillors recommended refusal of application 12/0971, Loretto, Aqueduct Lane and expressed concern about the expansion of the day nursery numbers.
- (ii) The notes of the Planning Group meeting dated 11 December 2012 (Enclosure C) were received.





It was agreed that the Council's application for section 106 monies should seek to deliver an expansion of the play equipment in Millennium Park and that enquiries be made regarding the cost of improving the quality of street light provision in the village.

It was further agreed that:

- the County Council be asked to convert the proposed pedestrian crossing on Bittell Road into a pelican crossing;
- Cllrs John Jagger and Rachel Banner contact the Barnt Green Quakers about facilities at the Friends Meeting House;
- A view be taken about the purchase of benches for Parker's Piece later in the 2013/14 financial year.
- (iii) It was agreed that Edwin Gumbley's request to withdraw from the Planning Group on the grounds of his unavailability during the day be accepted.

Cllr Charles Hotham withdrew from the meeting.

(iv) It was agreed that the Parish Council will not offer to manage the proposed car park on Fiery Hill Road.

#### (b) Environment

(i) It was agreed that where councillors had concerns about advertising within the parish that the matter be referred to the Planning Enforcement Officer. The Executive Officer was asked to contact the Planning Enforcement Officer about advertising outside St Andrew's School and the Sandhills Nursery.

Cllr Charles Hotham returned to join the meeting.

- (ii) It was agreed that the Environment Group arrange for appropriate plaques to be fixed to the oaks planed in Parker's Piece.
- (iii) Cllrs Hotham and Hawkley reported on their attendance at a public meeting to consider the Redditch branch line enhancement project.

As the Executive Officer is on leave in the period leading up to the consultation deadline in early February, councillors agreed to draft the Council's representation highlighting a concern about:

- the rail squeal noise nuisance;
- the car parking required to accommodate the increased number of trains.





It was further agreed that councillors should contact residents to canvass their views about the enhanced service.

#### 106/12 Community

It was agreed that the local community policeman be invited to speak at the 2013 Annual Parish Meeting.

#### 107/12 Governance

#### (a) Finance

It was agreed that:

- (i) the report of the Responsible Finance Officer for December 2012 (Enclosure D) be approved;
- (ii) the 2013/14 budget (Enclosure E) be approved;
- (iii) the 2013/14 Precept for Barnt Green Parish remain at £56,000 and that the Chair and Executive Officer be authorised to complete and submit the Parish Precept Form (Enclosure F) confirming this;
- (iv) a GBC Highspeed H318 A3 laminator be purchased at a cost of £149.90 (excl VAT) and that the purchase of a scanner be considered at a future meeting;
- (v) the Responsible Finance Officer, together with Cllrs Jagger, Davies and Hotham be authorised to invest, as appropriate, the money market deposit maturing in February 2013.

- (ii) It was agreed that the Finance Group should meet to consider the Council's standing orders and policy documents.
