9. Composting Unit

The Chairman reported that he had geld a meeting with interested parties – the Environment Agency, Worcestershire County Council, the District Council and a representative of the company operating the site. That meeting had been very constructive. A key point which had emerged was the need for members of the public who had complaints to register those complaints with the Environment Agency (on 08708 506 506, Monday –Friday, 8.00 am to 6.00 pm), on each and every occasion. It was only by this means that complaints could be associated with processes taking part at the site and thereby make possible identification of what gave rise to the incident.

With respect to allegations that the plant was operating outside the permitted hours, the Chairman suggested that 'operation' was capable of different definitions; it was not clear, for example, that weighing vehicles constituted an operation of the plant.

10. Role of Parish Lengthsman

The Chairman said that the role of a lengthsman was to undertake miscellaneous work that would otherwise fall to WCC to perform. This would include clearing some ditches and gullies, liaising with landowners about overhanging trees and cleaning road signs. A grant was available from WCC – currently of about £2,000 pa. A lengthsman would be an employee of the Parish Council.

It was agreed that, although the amount of the work done would necessarily be limited by the amount of cash available, some work was better than none. It was therefore <u>RESOLVED</u> that the Clerk apply to WCC for membership of the Scheme and advertise for a person to occupy the position.

11. Communication

The Chairman said that, Although Communication was on the Agenda, he was aware that any action agreed would have to be undertaken by the new Council to be elected in May. He therefore suggested that this item be postponed to the May meeting. The suggestion was accepted.

12. BT Phone Kiosks

The Clerk reported that a contract had been made for the purchase of the two telephone kiosks within the Parish at a price of £1 each. Ownership of the kiosks, and the responsibilities associated therewith, would transfer to the Council only after the telephony equipment had been removed; that date was not yet known.

13. CAPRI

Mr Gabbott, Secretary of RCAPRI, reported that the Secretary of State had decided to permit the construction of the pressure reduction installation, albeit under a number of conditions. He said that both CAPRI and Tewkesbury Borough Council had decided not o contest the decision by means of a Judicial Review. CAPRI would remain in existence and would keep a close eye on National Grid – which only that week had received its second fine from OFGEM, this time for reporting incorrect maintenance figures – to ensure that the company acted only in accordance with the permissions granted.

He said, as Clerk, that Chaceley Parish Council had written to the Council expressing their disappointment with the decision and suggesting that both councils write to TBC. It was agreed that this should be done.

The Chairman concluded by saying that although the final decision was not the one hoped for the results achieved by CAPRI were remarkable and well worth the effort. He congratulated CAPRI on having fought a first class campaign and wished them success in the task they had set themselves, one of which he fully approved The meeting enthusiastically indicated its agreement.
