# 5. Reports from District and County Councillors

#### Council's comments

Our concern regarding this proposal to bring forward the site opening time focuses totally on the impact to the approach road infrastructure.

Opening from 8.00 am would clash with both school and work traffic on an already busy stretch of road.

The impact of this clash can only be evaluated by traffic census monitoring, capturing volume and spread.

We request that the Highways dept conduct a thorough review and furnish the planning officer with their findings and recommendations

Because legal matters had not been finally resolved by WCC, it was agreed that the question of winding up the Sub-Committee be postponed until the next Council meeting.
