Ref:20/17 AONB Verge Project – With other local areas presently underway with this new initiative it was agreed to wait and assess the progress with them first before embarking on discussions with further landowners in the Parish who presently mow verges.

BT Pole along Marsh Road. Details with photograph logged with BT re Parish Council concerns on highway safety as regards the bracing pole on edge of highway.

Reference was made to a matter raised previously of improved road markings at Rye Cross to discourage motorists using the B4208 from overtaking. It is a staggered crossroads and often vehicles using A438 are crossing and unseen by overtaking vehicles approaching from the opposite direction. Clerk to contact highways for advice.

- Ref Minute 8/2017 Concerns continue to be expressed on potential flooding in Watery Lane. It
 was understood a pipe would be installed under gateway to Pink Cottage which has not been
 carried out. Clerk asked to contact residents and seek lengthsman's advice.
- Lengthsman has completed work around Rye Street culvert. Agreed that highways be asked if this
 could be jetted in addition to the culvert in Watery Lane and at Brook House.
- Further investigations to take place along ditch in Birts Street west side to ensure it was free flowing.
