111/19 Apologies

The Clerk reported on the resignation of John Nixon from his position of Tree Warden and he had sent him a letter of thanks for all he had done in tenure.

District & County Clir. Prof J Raine reported on several issues he had discussed with Hannah Davies, Highways Liaison Officer, including repairs to the footway by the village hall and improvements to drainage at the Blackheath Way/Park Road Junction.

The District Council was currently analysing its priorities which would be subject to public consultation and he was to look at the feasibility of ruinning a pilot recycling collection from public litter bins, possibly in West Malvern.
