It was agreed to submit the following responses:

20/00073/FUL: "The Parish Council wishes to object to the application on the following grounds: 1. The parking provision is inadequate. Eight spaces for eight properties is woefully inadequate and the consequential on street parking on Park Road would cause chaos.

2. The conversion to eight dwellings is over development. The access track is inadequate for that number of properties and there are few local facilities except a pub and a school to cater for the increase of probably more than 20 new adult residents.

3. The Parish Council understands that there are certain covenants in place restricting the use of the property and would like these made public to further assess the suitability of any variation in usage of the building.

4. The Parish Council would also like to know the long term plans for the section of the curtilage that is not included in this application "
