# 113/20 Apologies

#### 115/20 Reports from other representatives

To receive reports from County and District Councillors, Malvern Hills Trust, Tree and Footpaths Wardens and other representatives:

**District & County Clir. Prof John Raine** reported that WCC were currently assessing Highway budgets and asked for any recommendations for repairs to be forwarded.

**District CIIr. Natalie McVey** reported on the recent increase in Covid cases throughout the District and the three tier system currently in place. Care Home visits were currently not allowed and guidance for Remembrance events was awaited.

Charles Penn (Malvern Hills Trust) gave an overview of how the Trust had responded to Covid 19. No face to face meetings had been held since March and the car parks had been closed until June. Visitor numbers had increased greatly during July and had resulted in a large increase in litter but the situation had now returned to normal levels. Trust staff were now back working from Grange Road offices.

The following responses were agreed:

20/01327/HP - "The Parish Council has no objection to the application."

**20/01330/HP** - "The Parish Council has no objection to the application but advise that a darker wood stain may help to blend the new building in with the surrounding brick buildings."

20/01304/FUL - "The Parish Council objects to the application on a number of grounds:

- 1: The parking facilities are inadequate for a development of this size there is no turning facility and insufficient passing provision.
- 2: The bedroom spaces are understated Plot F01 (1 bed) has a studio that is larger than bedrooms in F05,F06 and F08 F01 should be classed as a 2 bed property.
- 3: Exterior waste bin provision is inadequate.
- 4: There are no vehicle electrical charging points.

The Parish Council also believes there are restrictive covenants in place which may affect the development and is currently investigating these."

**20/01347/HP** - "The Parish Council has no objection to the application but request that adequate sound proofing be installed to allay any local concerns of noise pollution."

#### 119/20 Playing Fields

Update on playground quotation: The quotation for the upgrade for the playground equipment had been circulated and further investigations were to be made for the installation of a new climbing frame unit. Further research was to be made into the creation of a bicycle 'pump' track.

## 120/20 Allotments & Community Woodland

Clerk to get quotation from Brian Witherford for a new fence around the area of the allotments where the skip is delivered. Several pedestrian gates in the woodland also required attention.
