Minutes of the Parish Council Meeting held on Monday 14th December 2020 Online.

139/20 Apologies

To consider acceptance of apologies for absence from Councillors: There were none.

140/20 Interests

i. Councillors Declarations of Disclosable Pecuniary Interests (DPI) and Other Disclosable Interests (ODI) regarding items on the agenda: Cllr. Turner declared an ODI on agenda item 10i since he had children who attended the school, but since the matter did not involve his pecuniary interests nor a planning application he was free to take part as normal.

ii. Notification of changes to the register of interests: There were none.

iii. To consider written requests from councillors for the council to grant a dispensation for those with Disclosable Interests to take part in discussions or voting: There were none.

141/20 Co-Option

To consider applicants for co-option onto the Parish Council: Chantal Baxter was unanimously approved for co-option and she duly completed her acceptance of office.

142/20 Reports from other representatives

To receive reports from County and District Councillors, Malvern Hills Trust, Tree and Footpaths Wardens and other representatives:

District & County Cllr. Prof John Raine and District Cllr. Natalie McVey commented on the damage caused to parts of the bluebell field by cyclists creating an off road track. The Clerk was to install a sign requesting the activity ceases and would monitor the results. No progress had been to resolve the deteriorating state of the Lamb Inn construction site and the Clerk was to write to MHDC for an update.
