

# Minutes of the West Malvern Annual Parish Meeting held at 7.45pm on Monday 8<sup>th</sup> May 2016 in West Malvern Village Hall

## **Present**

## **4. Duncan Bridges (CEO) and John Raine (Trustee and Chair of the Governance Committee) of Malvern Hills Conservators (recently rebranded as Malvern Hills Trust) will brief residents on the changes that have been taking place at the organisation that manages the Hills and Commons and that are the subject of a current review of powers and governance arrangements to equip it for the future including in a post-Brexit world.**

Mr Bridges outlined the changes which were taking place within the organisation as well as those proposed. This included a rebranding to Malvern Hills Trust which was considered to be a more user friendly name and one which stressed its charitable status. This had been in place from 7<sup>th</sup> April.

### **Chairman's Report:**

A gas lamp by the Brewers Arms had been damaged by fire but had now been repaired. The Parish Council had appointed a handyman to keep the bus shelters clean and to undertake various other tasks in the village.

He was please to announce that the Brewers Arms was to reopen on 20<sup>th</sup> May and wished the new tenant, Alison Mandrell, every success. A group had been set up to look at buying the pub from Admiral Taverns and a meting was planned for 19<sup>th</sup> May.

### **Tree Warden's Report:**

John Nixon and Robert Eyre's report was presented by the Clerk. Concerns had been raised by a resident concerning trees bordering a footpath off Montpelier Road. Other than that little of note had occurred.

### **Clerk's Financial Report:**

The Clerk presented draft accounts for the Parish Council. There were no queries.
