The following responses were agreed:

17/00328/HP - 'No Objection'.

17/00401/HP - 'The Parish Council has no objection to the principle of this development. However the roof angle of 45 degrees creates a structure that is taller and more dominant than seems necessary. If the angle were to be shallower we feel this would result in a lower structure that would be be more sympathetic to the surrounding area'.

## 61/17 Playing Fields

The Clerk confirmed that the damaged shackle on one of the swing chains had been replaced. He also confirmed that there was only sporadic evidence of residual knotweed on the bank by the football pitch and further spraying would be done to eradicate these.

The Clerk and Chairman had met with Paul Esrich from Malvern Hills AONB and Laura Wood, an ecologist with Worcestershire County Council, to review maintenance of the Bluebell Field. The display as usual was stunning but there were areas of bramble and raspberry which needed to be controlled. The bracken itself was beneficial to the bluebell development and was to be left. The full report was expected later in the week and a possible maintenance programme drawn up.

A tree survey had been undertaken and the report distributed to councillors. No major issues had been highlighted but some remedial work was suggested.
