125/18 Reports from other representatives

To receive reports from County and District Councillors, Malvern Hills Trust, Tree and Footpaths Wardens and other representatives:

In the absence of Mr Charles Penn, Cllr. Rouse reported on behalf of Malvern Hills Trust. He mentioned the improvement to a footpath adjacent to Townsend Way that had been funded from local S106 contributions. Also the deliberations over allowing access across Trust property to a potential residential development site on Chances Lane, Guarlford.

District & County Clir. Prof. J Raine reported that WCC were currently running a £12M deficit this financial year although certain savings had been achieved. The continuing financial rise of adult and child social care was the predominant cause. He also confirmed that he had recommended the planning application for 72 West Malvern Road to be considered by committee. This was expected to be on Wednesday 21st November.
