2 Minutes

5 To Consider Planning Applications received from Malvern Hills District Council for comment

The Committee carefully considered the under mentioned application which had been submitted by Malvern Hills District Council for comment. The Chairman closed the meeting prior to the discussion of the item to allow members of the public present the opportunity to comment on the application.

(a) MH11/00034/REM -application for approval of reserved matters re the construction of single dwelling at 27 King Edwards Road , Malvern

The Parish Council was unanimous in registering its strong objection to this application, the detail of which was not in accordance with the original outline approval given (approval 07/01497/OUT).

Members felt that this proposal submitted was substantially a new planning application and raised concerns that the proposed development would be totally out of character with other property in the area.

When the outline permission was agreed, it was for

- a. the building to be finished in roughcast to the exterior.
- b. a pitched tiled roof.
- c. windows to match existing local styles and colour.
- d. a structure that would be consistent with other properties in the vicinity.

These proposals submitted under this application differ significantly in so far as they include:-

- a. a flat roof
- b. an exterior finishing of wood cladding
- c. a balcony all the way around the building is proposed, finished in stainless steel and glass, which would result be completely out of character with other development in the area and would adversely affect the privacy currently afforded to neighbouring property.

The height of the roofline proposed is now greater than was shown under the original outline application that was submitted and the building now proposed would be overbearing and detrimental to the local street scene.
