# 5 Planning Applications received from Malvern Hills District Council

The Committee carefully considered the under mentioned applications which had been submitted by Malvern Hills District Council for comment. The Chairman closed the meeting prior to the discussion of each item to allow members of the public present the opportunity to comment on the individual applications listed.

## 11/01009 FUL - The Holywell, Holywell Road

Erection of a garden office and associated landscape works Members raised no objections to this application.

# 11/00146 FUL - 211-213, Wells Road

Conversion of two ground floors and upper floors into apartments New vehicular access and parking area.

Whilst Members raised no objections to the building conversion plans considerable discussion centred on the proposed vehicular access to the site and the road proposed off road parking allocations which had been submitted in support of the application.

Whilst the reasons for the recommendation by the County Highways Officer for refusal of the application were noted, Members were generally of the view that the proposed new access and car parking arrangements, which would allow vehicles to enter and leave the property off road in a forward gear, would be help to alleviate the current problems caused by roadside parking in the area.

Cllr Buchanan **proposed** that the application should be supported. This proposal was **seconded** by Cllr Black and on being put to the vote this was carried by 6 votes to 1 with Cllr Knibb requesting that his vote against the proposal be recorded in view of County Highways Officer's recommendation for refusal of the application.

# 6 Other Planning Matters

#### 11/00612/CPU - 80 Wyche Road WR14 4EQ

Application for a Lawful Development Certificate for a proposed use for the addition of 18 Photovoltaic panels to east elevation.

Following a question from Councillor Black the Clerk advised that application documentation in respect of this application had still not yet been received from the District Council and contact would be made with the relevant planning officer in order to progress the matter
