Construction of detached garage and timber cladding to be installed on part of existing dwelling house.

# 8 Planning applications received from MHDC for comment as follows: -

17/01936 FUL Arosfa Upper Welland Road Malvern WR14 4JU New dwelling including access off Upper Welland Road

Following careful consideration of this application Members unanimously resolved to register their objection to the proposals, on the basis that this development could contribute to the erosion of the 'green gap' between development in Upper Welland and the southern end of Malvern Wells

The site is outside the Parish Settlement boundary and development would be contrary to Policy SWDP2 of the South Worcestershire Development Plan.

Members were of the view that the development of this site could potentially set a precedent that other developers might seek to follow. Such developments, if allowed, could progressively harm the character, appearance and scenic beauty of the locality, especially in view of the sites location within the Malvern Hills AONB and its immediate proximity to the Conservation Area boundary.

The Parish Council did not believe that the proposal constitutes a sustainable form of development in accordance with the prevailing National Planning Policy Framework.

The planned style of the dwelling would be totally out of character with surrounding properties by reason of its planned style and mass.

Cllr Burrage abstained from the vote on the objections proposed in respect of this application.

There being no other business to transact the Chairman closed the meeting at 8.05 pm
