Update of the Alfrick & Lulsley Self Help Community plan. (circulated in advance)

Cllr. G Messervy-Whiting asked members to pursue details of those who could be included in the plan.

8.

Arrangements for Alfrick and Lulsley Horticultural Show committee's use of the Council's Playing Field.

The clerk said he had received a response from the Chair of the Show Committee (Rev Anne Potter) which he read out to the meeting. See appendix -c

Cllr R Ashton had sought out formal details (from MHDC) and informal advice on events on council-owned property, which had been circulated to members.

After a discussion it was agreed that Cllr A Hinton would produce a formal document based on this information for onward transmission to the Show Committee with an invitation to attend the next meeting (23/3/23) for a discussion based on this.

New Tennis Court - S106 funded project.

The Clerk reported that he now had the draft of a lease and accompanying 'side letter' from the Village Hall Committee and was waiting for a second quotation for the construction work.

It was agreed that the process of submitting a request for funds from MHDC would be that both the Parish Council and the Village Hall Committee would produce written confirmstion that the draft lease and accompanying 'side letter' were acceptable and would be confirmed on receipt of funding. The project with details of construction costs etc would then be prepared and sent to MHDC for approval.

Support the use of Speed Dummys (or Scarecrows) (circulated in advance)

Cllr Hinton said there was some concern over the effects these might have on horses being ridden on local roads. It was agreed the the council could not support a general use of these 'dummys' and it would be up to individual users to be responsible for their use and siting.

Clerk's Report -

The VAS was back from the manufacturer who had revised various settings and firmware. Whilst it still worked erratically at the Lulsley location, where it had previously operated satisfactorily, this site did not conform to the manufacturer's recommendations and at those sites that did meet these it performed satisfactorily.

It was therefore fit for purpose and he would withdraw the council's complaint against the manufacturer.

He was in the process of acquiring extension poles to enable it to be used at sites where the location did not currently meet the recommended dimensions.

He said that Suckley PC had not resolved their possible use of the 'old' VAS but if it was no longer required he proposed 'buying-out' Suckley Parish Council's share to enable it to be permanently in the parish, at a cost of £100. This was agreed.

- 1) Budget was approved at Full Council Meeting on the 16th February 2023. The increase was 2.94% increase plus 2% uplift in adult social care levy. There is a 5% increase for the lengths man's scheme, following 15% last year.
- 2) Re. Local Government Boundary Commission review of Worcestershire County Council, only limited changes are expected. The LGBC proposals are due post local elections in May and June 2023.
- 3) I am awaiting a date for the repair of footpaths, which are budgeted for at Clay Green 5-8 and Folly Road, near Rose Cottage.
- 4) The County Councillor's divisional fund continues, and I welcome requests.
