8. New Code of Conduct

This council resolves:

- a) To adopt the Worcestershire model code of conduct with effect from 1st July, and to delegate to the clerk the ability to amend the document as needed when a final version is made available.
- b) To delegate to the clerk the ability to make any changes needed to standing orders to allow the council to comply with procedural changes resulting from adopting the new code.
- c) That council members will register interests with the district council as soon as the regulations specifying them are published.

Agreed unanimously.

9. Informal Planning Group;

Report on the Public Meeting on 30th May, the development of a neighbourhood plan and establishment of a formal committee of the council to process this.

It was agreed to proceed to the formal establishment of a committee to process and produce a Neighbourhood Plan. There was a need to find five parishioners to join the five councillors currently involved and the clerk would draw up draft letters of invitation to those who had shown an interest in this.

10. Heating Oil Syndicate;

Cllr P Tebbit reported that he had attended a meeting at MHDC with representatives from neighbouring parishes and, based on the information he had gathered, would be contacting those who had expressed an interest in a purchasing syndicate with a view to establishing a working group who would take up the project.

11. Broadband Facilities in the Parish

The clerk reported that have studied the details of the schemes for funding support by WCC these were inappropriate for a small parish and he could not recommend taking up these proposals. He would continue to press WCC to either, propose financial help to individuals, as some local authorities are doing, or put pressure on the provider (BT) to improve the performance of the line from the Leigh Sinton exchange.

12. Clerk's Report - a) Actions from the previous meeting: b) Correspondence Received

a) The clerk reported that he had attended a briefing session on the Localism Act given by WCALC and he would be preparing the additional item (sect 7) of the Clerk's Portfolio to enable the council to acquire the 'General Power of Competence' under the Localism Act.

He was working to establish the registration of the council under the PAYE scheme but was being hampered by the slowness of the bureaucracy involved.

b) The clerk drew members' attention to the information being provided by WCALC on the new Code of Conduct for members and the rules for declaring pecuniary interests. He would keep members informed as the final details emerged.
