20.44	 Lengthsman Report & Highways Matters: Lengthsman report for the previous month is awaited. Clerk to chase up the removal of the Holly tree in the walkway behind Old Rectory Close. The 40mph sign from Malvern towards Colletts Green needs vegetation removing. An overgrown hedge outside 21 Winsmore needs a polite notice to cut it back – Clerk to ask the Lengthsman to attend. Housing authority also to be contacted. Notifications from Highways were noted – Road closure – Station Rd – 02/11/2020 for 12 days Derestriction sign towards Old Hills to be reinstated Jennett Tree Lane roundels have been reinstated Malvern Rd pathway surface outside Skoda garage to be monitored Parish street lighting – the parish lighting condition survey was noted, and the Clerk was asked to liaise with WCC re urgent repairs and the annual maintenance budget. 20.45	 Financial & Governance Matters: 1. Payments were approved as per the schedule. Proposed Cllr Huckfield seconded Cllr Phillips. All agreed. 2. Malvern Hills Trust Board Nominee – M. Alexander has been nominated to the MHT Board for the parish. 3. Six Month Rule for Councillors – the Clerk confirmed that Cllrs Harris & Humpage have now been granted leave of absence until 1st December 2020 – to be reviewed at the Dec meeting. 20.46	Strategic Planning: Neighbourhood Planning (NP) – still uncertain how much influence the NP has in light of recent Gov changes but still a benefit to the parish to have one. Discussion took place about what should be included, and it was agreed that it should be a simple plan to follow with approval from the local planning authority and should not include anything too prescriptive. 20.47	 Parish Matters: 1. Newsletter – awaiting distribution. All thanked for contributions. Pdf to be circulated by the Clerk. Next edition early Jan 2021. 2. Speed enforcement measures – Cllr Huckfield reported on the recent communication from Community Speed Watch (CSW), which confirms that the speed survey results show the 85 percentile as being too high for CSW to be appropriate. Mobile speed enforcement vehicles are now to allocated to the parish. 3. 'Operation Slow Pass' was explained by Cllr Underwood in respect of a cycling / driver initiative due to start shortly in West Mercia Police area. 4. BT Kiosks – Cllr Lamb still has to speak to Powick school re usage options. The Powick kiosk door appears to be jammed – Cllr S. Williams has done a temp. repair, but the Clerk was asked to contact the Painter and ask him to meet Cllr Williams to see what can be done. 5. Ash trees in Dark Alley - currently being checked re ownership by MHDC to see if the height can be reduced. 6.CL77 Access land at Broadfields Farm Lane – WCC has confirmed that six fields adjoining Broadfields Farm are common access land. 20.48	Powick Action on Climate Change (PACE): The recent newsletter insert has been produced and thanks were given to all concerned. PACE need to decide how often to do something similar. There was no LTP4 or ATC update. An audit of carbon neutrality could be undertaken to identify ways in which the PC could improve. A local contractor has offered to do this, and Cllr Underwood has a lost of initial questions we could ask ourselves free of charge – PACE could undertake this work. Cllr

20.49	Playing Field Reports: 1. Hospital Lane – work going well so far and ahead of schedule. Some local complaints received which have been dealt with as appropriate. Link Nursery is very supportive and was thanked for working with the PC to overcome any initial concerns. The MHDC Project Officer has been invaluable to the scheme. The current discussions regarding the ground source heat pump were noted and ClIrs Lamb, Phillips and the Clerk agreed to find the most environmentally friendly way forward which will also meet hot water demand.	Cllrs Lamb & Phillips and the Clerk to work with MHDC Project Oficer to find the best water heating solution.
	The excess soil has been deposited at the far end of the field adjacent to the A449 footpath – the Clerk explained the idea for a creative wildflower sculpture garden, working with a local Artist to design and create the scheme. The scheme will enable approx. £18k to be saved from disposal costs and reallocated to this, whilst also achieving an overall saving. It was proposed by ClIr F. Williams, seconded ClIr Underwood to reallocate funds subject to MHDC approval. All agreed. The Clerk will progress this with M. Hammond at MHDC and work with ClIr Underwood to draft the project spec. and find local Artists to contact.	Clerk and Cllr Underwood to progress the sculpture garden.
