- 2. Declaration of Interests

- 3. To consider written requests from Councillors for the Council to Grant a Dispensation (S33 of the Localism Act 2011): None requested.

- 4. Minutes: Having been previously circulated the minutes of The Parish Council meeting of 10th December 2014 were signed as a true and correct record.
- 5. Progress Reports: No matters arising from previous minutes. The Action Plan was reviewed and updated. Resolved to rebrand and re-launch the Parish Magazine - To explore printing and colour costs, advertising, invoicing and revamp the newsletter to be produced April/July and November each year for distribution by second Wednesday of each of these months. To trial for one year in the first instance. Work to be carried out by Collette Chappell who is to receive additional remuneration for her efforts. The large overgrown Leilani tree located in Grange Lane was inspected and it was thought that this tree belonged to the property owner.
- 6. Parish Lengthsman Scheme: An update was received as per worksheet.

 - Work on the Southern Link Road is causing traffic problems to be kept to a minimum level of disruption
 - Savings of £5M (out of £25M) need to be found for Financial Year 2015/16 Budget meeting to be held on 17.01.15
 - The road layby on C2066 Naples is closed between March and September 2015 for resurfacing work.
 - New campaign to reduce landfill. £600K pot of money has been allocated to support ' Love Food Hate Waste'
 - A Meeting is to take place on 22.01.15 regarding reducing/enforcing speed limits within the Hallow Division.
 - Gritting Highways now have high tech vehicles to carry out gritting operations. It is envisaged a better service will be provided in future.
 - 7.2 District Councillor: Cllr Swinburn.
 - Pre-hearing for SWDP process is underway. A principle day in respect of the Temple Laugherne Development is 4th/5th March 2015 to be held at Sixways. Since the last examination a new barrister has been appointed.
