4/02/18 Minutes of the Annual Parish meeting of the 14th August 2017 were duly approved and signed as a true record by Cllr Adams.

5/02/18 Matters arising from the minutes – Stoke Bliss Animal Rescue Centre. An update on planning matters was discussed.

6/02/18 (a) Cllr Ken Pollock – Worcestershire County Council

Tenbury Public Realm – This work is nearing completion. The new red tarmac on the raised tables is scheduled to be laid on the 5th March onwards, overnight, but please note that the work is starting at 19.00 and will continue throughout the night until 6am. It should not take more than 2 or 3 nights to complete.

SWDP revisions- Following its publication in 2016, the SWDP has been the basis for deciding the pattern of house building across south Worcestershire. Recently, the three councils involved have been considering revising the plan in the light of the impending publication of the second National Planning Policy Framework.

While this concerns the County Council more from the infrastructure viewpoint, Cllr Pollock has been keen to take part in the discussions. His impression is that while organic small scale growth of communities is desirable, it could be that larger new settlements may be necessary. Should one or two "new towns" of around 5,000 dwellings be required, the location of such developments is crucial. Any strong feelings on such plans would be welcome by your local district councillor and the planning departments.

Recently Tenbury Town Council considered an application to build 72 houses off Oldwood road opposite the high school. Cllr Pollock suggested that it would be advantageous to the school to have more young families in its catchment area. In

addition, it is unrealistic to suppose that homes should only be allowed close to where there is an unmet need for employees. Minimising travel distance to work is desirable, but often unrealistic, and could be seen as a reason for allowing rural areas to become depopulated.

Road improvements- There are two planned closures in the spring to deal with poor road surfaces. Between the 14th April and the 18th May, the C2088 in Bockleton will be closed for two days. Between the 30th April and the 31st May, the C2097 in Kyre will be closed for four days. Cllr Pollock stated that he trusted this will result in decent long lasting road surfaces in some difficult places in the parishes.

Velo Cycle Event - CSM Active have announced that they will not be seeking road closures for another cycle event like Velo Birmingham in 2017 for later this year. They are working on a similar event to take place in the spring of 2109, on a route as yet to be determined.

Divisional Fund- Cllr Pollock still has a reasonable sum in his Divisional Fund and would be pleased to allocate it to good causes. If anyone knows of deserving enterprises that could benefit for ma small sum, up to around £1,000, he would be pleased to talk to them about whether he could help.

Resolution: Cllr Adams thanked Cllr Pollock for his report and the report was approved.

(b) District Councillor Report from Cllr T. Penn and Cllr P. Grove.

Waste Changes

Letters concerning the changes were sent to all households in January. They stated whether the properties were considered suitable for individual black bins, communal bins or remaining on sacks. These have generated a considerable number of enquiries. Most are households requiring larger bins. To date, 650 requests have been accepted and these were received before the deadline, Wednesday 31st January. Homes who missed this date and who meet the criteria will have the opportunity to request a larger bin after 2nd April.

Extension of Mandatory Licensing

Subject to both Houses of Parliament approving the measures, mandatory licensing will be extended in April 2018. This will be for all HMOs occupied by more than five of more persons, in two or more separate households regardless of the number of storeys. There will also be mandatory conditions on room sizes used for sleeping, refuse disposal and storage facilities together with a licence discount for private providers of purpose-built student accommodation.

(c) April 1st 2018 Clerk Salary increased increment rise in line with JCC pay guidelines. Clerk salary to rise to spinal column point 20 and then annually on 1st April thereafter.
