Minutes of the Monthly Parish Council Meeting of Bayton Parish Council held in Bayton Village Hall at 7.00pm on Tuesday 20th March 2012

- 1. Apologies: Apologies were received and accepted from Cllr Taylor and Cllr Salisbury.
- 2. Declaration of Interest:

- 3. Public Question Time No questions were raised.
- 4. Minutes of Meeting held on 21st February 2012 were agreed by all and signed by Chairman.
- 5. District Cllrs report See report from Cllr Grove. County Cllrs report – Brief report given.

Phil Grove Leader of MHDC came to address concerns raised by Parish Council to District Cllr regarding WFDC proposals for a Gypsy/Traveller/ Showman site at Clows Top. Mr Grove addressed the meeting and felt the land could be best used for housing. He stated MHDC work closely with WFDC. He is to look into mains sewerage issues for the village. Clerk asked questions on litter picking and WCC agreement. Mr Grove to provide responses to all queries at April meeting.
