Possible Sale of the Village Hall

Clerk to report on progress on a detailed design for residential development and correspondence with the owner of the land adjacent to the hall on the north side.

The clerk read the correspondence between himself and the landowner regarding access to the woodland on Ankerdine Hill. He reported that he had reviewed the previous applications for access to this land and in his opinion there was no possibility that the council could support a similar planning application. He was asked to write the landowner suggesting that alternative locations for access to the woodland were considered in line with suggestions made during the previous application in 2002 and also indicating that whilst the council could possibly support a new application for access to the land it was not possible to link this to the sale of the land on the north side of the Village Hall to enable the conversion of the hall to aresidential dwelling.

Neighbourhood Plan - Progress etc.

Members noted the work being done by the Martley Group who were assessing historical features of the parish and also the report circulated in advance the meeting on the general progress towards the neighbourhood plan. It was agreed that little could be contributed at the moment and the matter would be further discussed at the next meeting of the council in May.

Parish Lengthsman Scheme - Documentation had been received for the 2015-16 year at a similar rate to the current year and would continue as before.
