## **Wildlife & Countryside Act 1981.**

### **Application by Castlemorton Parish Council for a modification of the definitive map and statement.**

Castlemorton Parish Council is making an application for a Modification Order to Worcestershire County Council in respect that a right of way legally exists but is not shown on the present map and statement.

The right of way is identified on the enclosed map between the crosses. **It is that part of the track between Walnut Tree Cottage adjacent to B4208 and the entry to Worcestershire Wildlife Reserve Footpath 535 (B).**

The Parish Council believes that this track has no known ownership and therefore should be registered on the definitive map and statement to show the existence of a right of way. Historically it seems as though this was once a 'parish road'.

Your completion of the Public Rights of Way Evidence Form (M.0.4) with your own evidence and information would be appreciated please.
