# **356/10 Planning Applications**

**10/1020 34, Church Hill, Belbroughton** – change windows to double glazed units. No objections.

**10/1015 2, Woodgate Way, Belbroughton** - two storey side extension. The Council has no objections in principle provided the plans meet guidelines relating to the visual impact on adjacent properties. It also appears from the plans that the proposed building line would be less than 1 metre from the neighbour's boundary.

**10/1057 White Lodge Barn, Holy Cross Lane, Belbroughton** creation of a private drive by utilizing an approved field access, and landscaping. The Council objects to this application which it considers to be an inappropriate development in the green belt. The Council also considers that the increased use of this entrance which would result from the granting of the application would be dangerous at this point on Holy Cross Lane. The Council suggests that if the applicants consider their current access road is hazardous they should seek improvements to this road to improve visability rather than a second access.
