Planning – Delegation to Clerk

- Cllr Wright thanked the residents Bretforton (and Offenham) for supporting him in reelecting him as District Councillor.
- SWDP- This is likely to be concluded at the latest Spring 2016. In view of the shift in planning applications and approvals now would be an appropriate time to reconsider requests to local landowners for the purchase/lease of land for allotments and other village amenities.

This will be advertised on noticeboards, webpage and any areas of the village felt appropriate. Cllr Grant to circulate.

ITEMS FOR DISCUSSION.

- 1. **Allotments- Land-**Next agenda. Sub-committee members to contact local landowners.
- 2. **Willow Trees-Back Lane-** Site meeting with tree surgeon carried out on 8th May 2015. Quotation due 13th May 2015, (not received) detailing removal of some willows, pollarding of others and replanting. Next agenda.
- 3. **Bretforton Memorial Hall i. Solar panels-** It was unanimously agreed that cllrs should meet on an informal basis and discuss projects that could be considered for village which would include a new village hall or upgrading of existing facility. No date was set.
 - **ii. Broadband voucher scheme.** The PC would be eligible for this scheme but superfast broadband would cost approx. £44 per month. Clerk to find out views of hall users for next meeting to assess whether facility would be cost effective. Cllr Wright will contact Wychavon It to see if there are any schemes available.
- 4. **Bretforton Community Club-** Next agenda to receive an update from Cllr Lisney.
- 5. **Village Posts-** Quotation was considered from M Parkinson. It was unanimously agreed to request a breakdown of costs and materials and to ask Orchard Fencing to quote for the works. Next agenda.
- 6. **Burial Ground- i Request for information relating to increase in burial fees**-It was unanimously agreed that Chair should respond to correspondence advising that it was agreed at the meeting on 13th March 2000 that an admin fee should be paid and that the Clerk or PC representative attends a funeral/interment so that the official paperwork advising that the event took place can be signed.
 - Ii. Correspondence relating to plot 600- Correspondence was read out with regard to the Petition for Faculty and emails received by Solicitor detailing that further information albeit 'hearsay' had come to light and that it should be considered that the petition be halted. Cllrs Davis, Cleveland and Wright had already approved this action in the knowledge of Cllrs and the matter was now ratified. It was also agreed that solicitor should be requested to provide proposals on the most appropriate course of action to now be taken by PC to minimise claims or re-occurrence.
 - iii. **Memory Lane Memorials-** It was agreed that Memory Lane would be considered when carrying out BG works.
- 7. Rural Communities Programme- i. How successful is Bretforton. www.wychavon.gov.uk/rural It was agreed that survey should be carried out.

ii. Door Knocks- It was agreed to request inclusion in

the scheme.

iii. Welcome to Village Pack- It was agreed to

request inclusion in scheme but to find out how scheme would work, how would data be captured and could information relevant to Bretforton only be included.

iv. Community Folder- It was unanimously agreed to trial a folder which will be in Community Shop, flyers have been put in all noticeboards notifying residents.
