163. Apologies

Apologies were received from Councillors T Botterill and County Councillor Ian Hardiman.

Public Question Time

Mrs Yolande Biggs addressed the meeting and spoke in support of alternating meetings between Cookley and Wolverley as then probably more Cookley Parishioners would attend, she queried whether a room at Cookley Playing Fields and Village Hall could be used. She also asked what the Parish Council felt about the Outline Planning Application at Lea Castle not being refused? She felt the interview with Ian Hardiman highlighted poor road access which will get worse with the development. Councillor J Hart responded that the Parish Council did support development of the former Lea Castle Site but raised issues on the infrastructure, traffic, schools etc. Councillor C Nicholls strongly voiced his concerns over the lack of infrastructure, transport, schools, surgery etc. Councillor J Hart stated that the plans submitted did include provision to improve the situation, money will be put aside and plans are only in outline at the moment and only for up to 600 dwellings. It will be crucial to scrutinise the detailed plans when received.

Mrs Katrina Willetts asked why Wolverley did not want to be part of the Neighbourhood Plan. Councillor R Drew explained that Wolverley are in total support of a Neighbourhood Plan but due to the enormity of the task to undertake this felt that initially the Neighbourhood Plan area should be contained to Cookley and Caunsall, no Wolverley Parishioners had expressed an interest and the Plan can later be expanded to include Wolverley.

These having previously been circulated it was resolved unanimously to receive and adopt the minutes as a true record of the meeting and these were signed as such by the Chairman.
