Loft Conversion with dormers to left and right elevations. Recommend Approval

Erection of single pole with a transformer under existing overhead line. Recommend approval

The same applicants had their original application (6/9/2007) turned down because it failed to respect the scale of the original dwelling. Bredon Parish Council objected to that application. The Planning Officer considered that the proposed alterations would result in a structure that

was substantially larger than the original building which would seriously detract from its character, contrary to Policies SD6 and CTC1 of the Worcestershire County Structure Plan, and Policies GD1, GD2, SUR1 & SUR6 of the Wychavon District Local Plan.

The applicants submitted a revised application (15/1/2008) which addressed these concerns by reducing the scale of the development and maintained some of the original character. The Case Officer recommended approval because the new design was more sympathetic in scale and maintained a clear divide between the dwelling and the garage. We supported this revised application.

The same original objections apply to this new revised application as to the application of 6/9/2007. We oppose the application for the reasons cited above, that is the application in total completely fails to respect the size of the original dwelling, by applying to convert the approved garage to living accommodation and adding an additional large structure to the rear, far in excess of the approved footprint area.
