# 9. Planning:

- a) To be Ratified:
  - i. 21/01113 71 Blenheim Drive, Bredon, GL20 7QQ Single story extension to side and rear.

No objections in principle. However, flat roofs conflict with the Neighborhood Plan and if the Officers approve the plans, the flat roof should not be used as a balcony.

# b) For Approval:

i. 21/01186/CU Mill End House, Mill End, Bredon, GL20 7LQ Change of use of existing outbuilding to dwelling, and erection of replacement garage.

No objection in principle, but object to the height increase in the existing outbuilding. Also request that a condition of approval is the garage is attached to the dwelling, to restrict the building's use being ancillary to the main dwelling in perpetuity.

ii. 21/01253/HP 34 The Dell, Bredon, GL20 7QP Two storey rear extension.

No objections in principle, however, it is requested that the flat roof element is not used as a balcony or similar, as this conflicts with both BNP & SWDP 21.

DKE Audit Services and Worcestershire CALC had recommended that the parish council should review its operating structure for Planning matters to ensure it follows the requirements of the

Good Councillor Guide 2018. The Planning Working Group comprising Cllrs Bradley, Coghlan, Handy and Pyke met to discuss the future workings of the Group and the need for enhanced transparency.

After discussion, it was **agreed in principle** to operate as a Planning Committee with formal advertised meetings every 3 weeks with notice, public attendance, declarations and minutes. The parish council would delegate responsibility (i.e., executive powers) for certain decisions to the Planning Committee who can then report its decisions to the full council.

The Planning Working Group will draw up Terms of Reference for approval by the parish council.

- e) Freedom of Information (FOI) Requests (SWDP).
- The Freedom of Information (FOI) requests from relevant Tewkesbury Borough Councillors and Planning Officers are still awaited. Wychavon have confirmed they will comply with the Clerk's revised request for emails with Tewkesbury Borough Council, discussing the Ashchurch Bridge over Rail (ABoR) from October 2020 to 31<sup>st</sup> March 2021.
- f) Gloucestershire & Worcestershire Parish Councils Association (GWPCA) Update. Cllr Whiting left the meeting for this item. The Ashchurch Bridge over Rail (ABoR) forms the first part of infrastructure for the proposed Tewkesbury Garden Town, with the bridge having been indicated as having the potential to unlock land which could deliver 3,000 new homes between Northway and Kinsham. An application has now been submitted for a Judicial Review, which seeks to quash the approved ABoR planning decision. This process is being undertaken by Ashchurch Rural Parish Council, with the support and assistance of Bredon Parish Council, Northway Parish Council and Kemerton Parish Council. Tewkesbury Borough Council's defence/rebuttal is awaited. The GWPCA Constitution is being formed with associated web site, go-funding options and a communication to the parish councils who have responded positively to an involvement. An initial proposed meeting with Tewkesbury Borough Councillors has been declined.
  - g) Other Planning Matters.

It was noted that roofing work is being undertaken at The Old School House in Main Road which may have listed status.

## 10. Covid-19 Update.

The Government decision to delay restrictions until 19<sup>th</sup> July 2021, will delay the return of some organisations to the Village Hall.

# 11. Bredon AFC External Area Proposal.

Bredon AFC submitted a proposal for the outside space between the Clubhouse and MUGA to be in line with government guidelines/best practice. This requires permission to sink 4 x 1 metre square concrete bases which would allow the installation of retractable all-weather coverings. After discussion it was decided the current temporary arrangements, with outdoor seating to facilitate outdoor socialising, were adequate for Covid-19 compliance. There were also concerns about proximity to the MUGA and alcohol being consumed on the Playing Field. It was **agreed** to reject the proposal. Cllr Falvey abstained.
