i) Bredon Hill Conservation Group.

At the previous meeting of BHCG on 7 April it had been agreed by all Representatives that the secretary, Willy Ford, would send in the Group's response to the Village Site Allocations Consultation (SAPP), which proposed sites for new housing in most of the Bredon Hill parishes. This consultation is of key importance, and is central to the Group's purpose. It appears that the response has not yet been made Bredon wrote to the secretary on 15 May asking for further details, but has not received a reply.

j) Parish Plan.

On going, Cllr Rhodes and Darby had attended a meeting held by Wychavon. Wychavon has employed staff to help with Village Design Statements and Parish Plans. The change of

I) Motorway Noise.

Cllr Darby has written to the Highways Agency requesting that Bredon be rated as a 'First Priority Location' in the current M5 Noise Action Plan. In the medium term this could lead to the installation of a quieter surface and noise barriers adjacent to Bredon. Cllr Darby had also contacted Cllr P Davey (Droitwich) and Harriet Baldwin MP for help and advice.
