#### 10. To Discuss Flooding at Kinsham.

The Council has applied for a £5,000.00 grant for flooding work as The County Council will not carry out work on the main road in Kinsham until a culvert in Lower Lane Kinsham has been enlarged, the council agreed to use this money to have the works in Lower Lane carried , the site is currently being surveyed.

## 11. To Discuss Cherry Orchard Play Area.

Due to the dissatisfaction of several residents of Cherry Orchard, the Clerk contacted the contractors to ensure that the area was being mowed according to the contract. The council agreed to have the area sprayed with week killer and to tale up the offer of assistance of this area, subject to negotiation.

#### 12. Items For Future Agenda.

The footway between the Jubilee car park and Brensham Court and Bredon Dock. The wooden installations near Kemerton Lake were made by thirty-two architecture students from around the country participating in a design workshop called 'Studio In The Woods'. All of the objects were designed and constructed over two days using timber grown and sawn on site. The students were evaluated by two architects of world-renown, Ted Cullinan (winner of the RIBA gold medal) and Peter Clegg (winner of the Stirling Prize). All of the objects are temporary in nature.

The Chairman informed the council that two organisations had been contacted regarding their future use of car parks in the parish, with a view to obtaining revenue.
