The minutes of Bredon Parish Council meeting held at Bredon Village Hall on Monday 3rd March 2014 at 7.15pm.

Mr P Whitehead informed the council, of his understanding of the developments at the woodlands at the rear of Perwell Close. The Forestry Commission has confirmed that a 'restocking notice' was issued to the owner in October 2013, as no appeal was lodge in the time period allowed. Regular inspections will take place to ensure that re stocking has taken place by July 2015. The restocked trees are not allowed to be felled for ten years; however this could be overturned by a successful planning application. Mr Whitehead will be asking ClIr Hardman, if this area can be included in the conservation area.

Mr Frampton made the following points:

- Thanked the council for contributing to the new footpath either side of Cheltenham Road near the Village Hall.
- Brensham Court residents will continue to support the council in opposing the Planning application no. W/13/02148/OU.
- Thanked the council for pruning the tree on the playing field that overhangs his garden.
- Apologised as due to unforeseen circumstances, he had not planted all the bulbs that he
 intended, however this is an ongoing task and for not watering the hydrangeas enough.

Mr Stuart Adam (Head Junior Coach), a junior school teacher and FA registered coach and Mr J James Caveny, (Junior Football Manager) from Bredon Football Club updated the council on their progress since they attended the meeting in September 2013.

On Saturday mornings they currently have just over 30 children between the age of 4 and 11 and three coaches training, to FA standard of which respect plays a great part.

Each child pays a £10.00 signing up fee and £1.00 per session, the funds are kept solely for the Junior Division which is a separate entity with its own committee within Bredon Football Club, to date funds have been spent on equipment and kit.

The next stage is to apply to join the Ambassador League which covers the Evesham area.

Councillors asked questions which were duly answered, they will give a further report in September 2014.

Mr P Whitehead, Mr Frampton, Mr S Adam and Mr Caveny left the meeting.

- iv. W/13/02545/PP Land adjacent to, Gravel Pits Close, Bredon. 6 dwellings, with relocation of existing garage to No 6 Gravel Pits Close to facilitate new vehicular and pedestrian access. Although the council does not welcome the addition of six houses at a time when there is already a large amount of new housing planned, there are no strong planning grounds for opposing the application. The council will not object to the proposal, but it will seek to ensure that a proportion of the new housing is affordable.
