#### 1. Election Of Chairman.

The outgoing vice chairman, Mr Handy, presided over the election of the Chairman. Cllr Darby proposed, Cllr Sly seconded and it was unanimously agreed to elect Cllr Handy as Chairman.

#### 2. Apologies For Absence.

  - iv. W/15/00844/PP Frannan, Eckington Road, Bredon. Demolish existing dwelling and erect semi-bungalow with integral garage. The council has not reason to object.
  - i. 15/014013 Field SO 9239, Eckington Road, Bredons Norton. Change of use of land from waste ground to mixed use for stable and keeping of horses and caravan site for single Gypsy family with associated development (improvements to vehicular access, internal access track, hard standing, stable block/utility block, septic tank and retain electricity junction box). The council agreed to object to the proposal.
