#### 11. Planning.

- a) For Consideration.
  - I. W/15/01192/PP Church Cottage, Manor Lane, Bredons Norton. Garden room lean to extension. The Parish Council is not aware of any strong planning policy grounds for objecting to the proposal. This is a sensitive cottage, formerly listed Grade 3 and now a 'building of local distinction' in the Conservation Area Appraisal. It's also in a sensitive location, being adjacent to the lane leading up to the church, and very much within the setting of the listed church. The front of the cottage is very attractive currently. All of which would argue against the extension. That said, this is a small cottage, with no room to extend it at the rear. We can see that the extension would make a big difference to the owners. Overall, provided the extension matches the existing building in its use of materials as has been proposed, we think it would be acceptable. This response is a general observation and should not be taken as objecting to or supporting the application.
  - II. W/15/01713/PP The Cedars, Westmancote, Bredon. Erection of single storey extension to provide utility and garden room as approved under permission ref no. W/14/02116/PP but without compliance with condition no. 4 (to amend approved plans, change elevations and floor plans so as to include balcony). The Parish Council is not aware of any strong planning policy grounds for objecting to the proposal. This response is a general observation and should not be taken as objecting to or supporting the application.
- III. W/15/01427/PP Hop House, Manor Lane, Bredons Norton. Proposed two storey side extension. Single storey rear extension. Conversion of existing garage into Dining Room. New glazed canopy to rear elevation & associated internal and external works. The Parish Council is not aware of any strong planning policy grounds for objecting to the proposal. This response is a general observation and should not be taken as objecting to or supporting the application.
