

**MINUTES OF INKBERROW PARISH COUNCIL MEETING HELD IN THE VILLAGE HALL, SANDS ROAD,  
INKBERROW ON WEDNESDAY 19<sup>TH</sup> APRIL, 2017.**

**DEMOCRATIC FIFTEEN MINUTES PUBLIC QUESTION TIME.** Mr. C. Willis asked when the grass cutting season in the village would commence and Mrs. Iris Smith again raised the serious condition of the pavement along Stonepit Lane. Replacement OS map for the Village Green notice board would be chased.

2290. **APOLOGIES FOR ABSENCE.** Apologies for absence were received and accepted from Cncllr. Dinah Griffin and Janet Cresswell, Clerk.

2291. **DECLARATIONS OF INTEREST.** Cncllr. Elizabeth Collins declared a none prejudicial interest in planning application for Priory Business Park. Cncllr. Richard Jordan declared a personal interest in planning application 17/00532. Both Members signed the Declarations of Interest book.
