#### 1. Election of Chairman.

# 11. Highway Matters.

a. Speeding in Winchcombe Road and the placing of a 7.5 weight limit.

The council is not happy with the Highways findings, after consulting with a highways officer from another county, the chairman would like this reviewed.

The chairman will write a statement to be circulated to the council before, being sent to Cllr Eyre's to take to the appropriate county council officer.

The safety element has been bought up in New Homes Bonus consultation process.

One option would be to have the Winchcombe Road stop, at the junction with Main Street.

b. VAS.

SeSeME are happy to carry out the moving of the VAS, however the posts in the Cheltenham Road are too tall, Cllr Eyre to speak to Highways Officer regarding a reduction in height.

c. Rights of Way.

All concerns regarding public footpaths should be addressed to the Countryside Officer at Worcestershire County Council.

The footpath bridge crossing a tributary into the river on the west side, joining Sedgeberrow to Wormington has been replaced, clerk to contact Wormington to inform them.

Cllr Morris reported that the bin in the centre of the playing field is not being emptied – Clerk to check with Wychavon however it is thought that this is not carried out by Wychavon and is the responsibility of the Village Hall Committee.
