### 2010.33 Inclusion of items in the Parish Magazine.

### 2010.27 Public (Highways) Meeting (23/3/2010) & Whittington Annual Parish Meeting (28/4/2010).

Public Meeting: Whittington's highways - their problems and future. The arrangements for a public meeting on 23<sup>rd</sup> March 2010 were noted and it was agreed to make a leaflet drop to advertise the event appropriate action. The meeting would start at 20:00 hrs. County Councillor Derek Prodger, Roy Fullee, and Rob Adams were expected to be present + possibly a representative of the Accident Studies section.

The Clerk suggested that the following were likely topics for discussion:

Worcester Transport Strategy Speed Limit on B4084 Pershore Road

Lane & Roundabout markings and signage for B4084 & J7 Road drainage.

Church Lane. Potholes & sunken drains/gulleys in carriageway. Supply of grit to grit bins.

VAS/DFS

Whittington Annual Parish Meeting 28th April 2010.

The Meeting was to start at 19:30 the Clerk suggested that the formal business dealt with first which should take until approx 20:00 depending upon contributors.

The second part of the meeting would comprise a presentation, the Chairman had provisionally ascertained that S. Birch - Head of Trading Standards and Waste Management @ WCC - would be willing to provide a 20 minute talk and take questions. This was agreed by all present and the Clerk was to confirm arrangements and contact participants as necessary.

The Clerk was to prepare an appropriate leaflet advertising both meetings, in consultation with the Chairman who would co-ordinate delivery.

#### 2010.28 Worcester Transport Strategy.

Members considered the draft response prepared by the Clerk. Amendment of item 2.d. was requested to follow a line that whilst the Council realised that there would be legitimate concerns in those parishes more directly affected WPC favoured the NW Link Road. Item 5.a. was also requested to be amended to relate to Whittington supporting existing proposals and their extension in the locality. Subject to amendment of these items it was agreed (MB/SM) unanimously that the Clerk be instructed to respond along the lines of the draft.

## **2010.29** Standing Orders and Financial Regulations.

The Clerk reported on the recent changes to NALC's Model S.O.'s and suggested there might be a need for revision to the Council's Standing Orders and Financial Regulations.

Members felt that any action now would be precipitate and asked the Clerk to place the matter on a future (probably July's) agenda

## **2010.30** District and County Councillors' Report – For Information.

County and District Councillor Adams reported increases in Council Tax requirements of 1.94% (WDC) and 2.5% (WCC). He had compared the WPC's precept with others in the District and felt it was slightly below average for similar size councils. He reported the official opening of the Envirosort plant at Norton (MB indicated he had been invited) with presently 200 tonnes per day throughput due to increase to annual levels of 52k tonnes in April; 64 tonnes in July and 105 tonnes by the end of the year. He also supplied contact details for groups wishing to visit the plant.

He referred to the Pershore Forum event planned for later in the week and hoped to see some representatives of WPC there.

The County was continuing to promote the Worcester Parkway facility at Norton, but the Dept. of Transport, and rail/train operators were not supportive.

# **2010.31** Police Report – For Information.

PCSO Fogwill reported during the Democratic Period to allow his early return to other commitments.

He indicated that a substantial number of calls (52) had been received from "Whittington" at least 32 of these related to Motorway matters. Only two crimes had been recorded which related to incidents involving action in Whittington not necessarily arising there.

Motor Cycling on the bridleways and footpaths to and under the M5 was again presenting its head but this was being watched and action would be taken if necessary. Improved liaison arrangements were agreed with the Chairman.

### 2010.32 Reports by Councillors, and Items for Future Agendas.

- a) To receive the reports of Committees and Working Groups and of Councillors representing the Council on outside bodies, to ask relevant questions, and to consider appropriate action.
  - Envirosort Site, Norton (CMRF) Liaison Group: The Chairman referred to the previous comments.
- b) To receive reports of Councillors on other matters.
  - The Chairman reported that R.A. Phillips had retired from the Council as he expected to take the Chairmanship of the Village Hall Committee at the end of March and would need to concentrate his energies there to progress the redevelopment of the Hall. The Clerk had formally acknowledged the resignation and he (the Chairman) would be writing to recognise Roger's loyal and long service.
- c) To note inclusion of specific items on a future agenda.
  - May 2010: Wychavon Games 2010 and Clerk's Holiday Arrangements May to 15/6

- c. Proposals for Expenditure. To consider proposals for expenditure.
  - i) <u>Budgeted expenditure</u>: Members agreed to the purchase of "Standing Orders for Local Councils" at a cost of £15.00 (HPC was willing to share the cost).
  - ii) Other expenditure: Requests for funding from Macmillan Cancer Support and Wychavon CAB requesting funding assistance were considered but not accepted.
- d. Adoption of Quarterly a/c report as at 31/12/2009: The Clerk explained that this item had been overlooked at the January meeting. Members agreed the report without further comment.
- e. Other:
  - The Clerk referred to the resignation of R.A. Phillips which left the Council without an R.F.O. and offered to accept this responsibility until the Annual Meeting in May. The offer was gratefully accepted (MB/SM) and the Clerk appointed R.F.O. pro tem.
  - ii) With the approach the end of year he sought approval to make virements and transfers to reserves as necessary to complete the accounts in good order. Councillors authorised (MB/SM) the Clerk/RFO to do so.
  - iii) The Clerk reported that WPC's long term investment in the form of a high interest deposit bond matured on 6/4/2010 and sought instruction. After considerable and heated debate as to the poor investment return offered by this form of account, it was agreed that MH would investigate the situation and inform the Clerk of possible alternatives within one week. The Clerk/RFO was delegated to make the decision based on such advice, where to place the moneys taking into account access, security and return.

A positive response from Roy Fullee to request for replacement of speed limit repeater signs on Whittington Road was reported.

New Matters:

WCC had notified closure of Church Lane from 5/4/2010 (probably for 2 weeks) for drainage works. Enquiries made in the hope that this included the sunken drain grate opposite Goldcliffe, had elicited that the work comprised new road drainage and gullies on the stretch from Old Road to the bend opposite Langland.

#### Traffic Management:

#### Previous Matters:

MB reported continued "all day" parking on the private access on the North side of the B4084 just East of J7. The police were unable to take action re the parking as this was private land, but could act on littering if provided with evidence. It was agreed (MB/GLC) to instruct the Clerk to write to the owners (Spetchley Estates) seeking their co-operation to prohibit parking on their access road.

Request for lane markings and signage to be provided on the A44, approaching J7 of the M5: R. Fullee (WCC) had responded that this would be assessed as part of the speed limit review. Apart from identifying appropriate speed limits for this road, signing and lining may also form part of any proposed improvements.

Barriers at the Swinesherd roundabout: R. Fullee had reported no progress and apologised for the delay.

New Matters: None

## b. Byways:

### General:

Parish Paths Warden: Members were updated by the Clerk & Chairman as to the situation vis a vis the appointment of M. Lodge as PPW. An invitation to nominate Parish Tree Warden had been received.

Whittington Tump - access: No action had taken place in the village. The situation was reviewed by the Clerk and Chairman for the benefit of Members. It was acknowledged that if anything was to happen to reinstate access to "The Tump" action was needed in Whittington. The Clerk indicated that evidence needed to be gathered to prove that a right of way had been created by usage over many years and that this needed local input.

Those members of the Council who had long term knowledge of the situation were asked to provide their own statements, and Parishioners were to be canvassed at the forthcoming Public and parish Meetings to contribute any evidence they might have. WPC Members were to seek likely witnesses locally.

The Chairman of Norton Juxta Kempsey PC had contacted the Clerk to offer assistance in obtaining evidence from his parishioners.

## **Bridleways & Footpaths:**

During discussion referred to above it was reported that the Bridleway (No's. 577,578, 579 and 504) & Footpath (No. 583) to Norton was obstructed by locked gates and electric fences. The Clerk undertook to report these to the Countryside Access Officer.

### **2010.26** Training.

The Clerk sought Council's approval for his attendance at Worcestershire SLCC Inaugural (Branch) Meeting & I.T. training day at Pershore £25 on 23/3/2010. HPC was willing to share the costs. His attendance was authorised (MB/SM) The Clerk suggested that it would be simplest and equitable if WPC paid for the book - purchase approved at 2010.24 c (i) and HPC for this training, which apportionment was accepted by Councillors.

WMRSS: } Tibberton V.H. on 6/3/2010and undertook to update } Members as more information was received.

Wychavon D.C.: Previously the Clerk had been asked to look into the need for planning consent for the alterations at The Archdeacon's House, Walkers Lane. WDC had advised that none was needed, all - except the change to the access - being "permitted development". As it appeared that the work was being completed and the driveway had been permanently altered the Clerk had sought advice from WDC. It transpired that this too was "permitted development" as Walkers Lane was an unclassified road.

Some Members were incensed at the insensitivity of the design, the lack of opportunity for consultation, and at the way in which work had been conducted without regard to neighbours or other users of Walkers Lane. It was agreed (MB/SM) with one abstention (M. Hallmark) that the Clerk be instructed to write to WDC expressing the Council's concern at the nature of the construction which was considered out of character with the area, the lack of consultation, the lack of consideration for road users, and the damage occasioned to the road outside by construction traffic.
