- Some delay to works being carried out due to flooding taking priority locally
- Rural Services are working on possible solutions to recent rural bus service cuts

- a) Chairmans report

- b) Village trust
 - · Looking for a new cleaner 15 hours a month
 - A work party started clearing the play area site which is now closed to the public, hoping to start work early April to be finished by end of May. Home Farm Nurseries have been awarded the contract (local firm)
 - · Mowing starts in March again
- c) Village shop
 - Reviewing shop fittings and will apply for a Post Office grant to fund any refurbishments
- d) PACT

- e) Lengthsman
 - · Report submitted of all works undertaken- going well
- f) Footpaths
 - Footpath from wassail corner to Pinvin all been cleared but there is a gate which isn't very accessible which is being looked into
 - · Badger Set collapsed locally

 - A water level marker is required at the Mill from the Environment Agency
 - · Several man hole covers are sinking on the High Street-needs addressing
 - Checked on whether a white line in the road would be feasible at Canada Crossing but the road is too narrow

 - BWB consultant Stuart Nelmes has submitted a report back with options for a flood alleviation plan
 on the south side of the village. This will be discussed at the next flooding group meeting and then
 presented at the May Parish meeting where funding can be considered.
