1. Apologies:

Apologies were received from Cllr John Brodrick

2. Declarations of Interest:

Councillors were reminded of the need to:

3. Minutes:

The minutes of the Parish Council Meeting held 15th November 2010 were approved and signed as being a correct record.

4. Progress Reports:

a) Clerk:

i. Insurance damage claims The Green

Accident 10th Nov 2009. Clerk still chasing recovery of £125.00 excess from insurers, Allianz.

ii. Highways, Hedges, Potholes

- a) Pear Tree Inn at Smite No response from hotel owners received to date. Clerk to refer matter to Highways Dept at Wychavon DC
- b) Salwarpe Bridge Response from Worcs County Council Highways states the condition of Salwarpe bridge is being monitored on an ongoing basis. Clerk to check if a Tell Tale Crack Monitor is being used.
- c) Offerton Lane Cllr Jim Brodrick reported that West Mercia Police had recently announced action will be taken against motorists who illegally park on roads and verges along the A4538 Pershore Lane, Warriors Way and parts of Offerton Lane, where rural clearway orders are in place. Officers will be patrolling these areas to enforce the traffic order, which means police can issue tickets without displaying the yellow no-parking cones. Situation to be monitored.
- d) Pershore Lane: Action brought forward from previous minutes. Clerk to write to Highways requesting investigation following 5 vehicles over the past two years crashing through the west side hedgerow on A4538 Pershore Lane, where there is negligible verge after the Canal bridge from the severe bend where the road narrows and the road is marked with double white lines, (opposite the cottage named Maxway).

- e) Hindlip Lane junction with Pershore Lane Action brought forward from previous minutes. Clerk to pursue Highways on the continuance of double white lines up to the lane junction to prevent cars overtaking as cars pull out of the lane.
- d) Drury Lane Overgrown brambles now cleared.
- Middleton Bridge Lengthsman has carried out works to ensure brook is not blocked.
 Clerk to contact Highways Team to request repair works are carried out to the posts and barriers.
- iii. **Lengthsman Scheme -** Lengthsman carrying out works in accordance with agreed schedule. Clerk to provide update on progress at next meeting.
- iv. Court Farm Enforcements Considerable concern continues to be expressed by Councillors on the unauthorised activities continuing at Court Farm, including the following recent actions –
 - The unauthorised felling of trees behind Woodside Cottages, in Hindlip Lane between Christmas and the New Year period. This woodland site is covered by a TPO.
 - The unauthorised signage advertising the site as the proposed location of the Hindlip Sports Village.

Agreed that the Clerk should write to Jack Hegarty, Managing Director at Wychavon DC, giving a summary of issues of concern and requesting his involvement in ensuring enforcement action is undertaken.

Clerk also to contact CPRE invoking their support on lack of enforcement action since 2009 on the deterioration of the Listed Dairy building at Court Farm (IN/09/02978/LB) and the removal of tiles on surrounding buildings within the curtilege of the Listed Buildings (IN/09/00577).

v. Worcester Rugby Club Signage – A large amount of unauthorised advertising signage has been erected on the grassed embankments surrounding one of the training pitches. This has been reported by the Clerk to Wychavon DC and a retrospective planning application is awaited.

Chairman to review original planning application documents to check if there is a breach of conditions under the landscaping scheme.

b) Chairman

i. Public viewings of major planning applications

The Chairman reported the public exhibitions for the Copcut Rise application and the Marina proposal at Cummins Farm had been very successful, with over 70 residents attending the viewing at the Baptist Church in Fernhill Heath.

Residents views have been welcomed and considered in the Parish Council responses to Wychavon District Council.

ii. Forthcoming May 2011 Parish Council Elections

The Clerk issued a timetable of proceedings for the forthcoming elections on 5th May 2011 and instructed Councillors on eligibility criteria and the steps they should take if they wish to stand again for election.

iii. Royal Wedding 29th April 2011

It was agreed the Parish Council should be involved in a joint committee with the Village Hall and the Parochial Church Council for proposed activities in celebration of the Royal Wedding.
