3. Minutes:

The minutes of the Parish Council Meeting held 19th November 2012 were approved and signed as being a correct record.

Cllr Jim Brodrick entered the meeting at 7.05pm.

- 4. Clerk Progress Report on actions from minutes 19th November 2012
 - a. Highways, Hedges, Potholes, Lengthsman
 - i. Clerk to follow up:

Highways team

- Request member of Highways team to walk lanes with a Councillor to highlight urgent repairs required.
- Vergemaster marker posts in Pershore Lane were missing.
- Highways maintenance of vegetation on Pershore Lane (Ragwort) was on the Highways maintenance schedule.
- Potholes along Strand Lane, Ladywood Road, on Middleton Bank have been reported to Highways.

Lengthsman

- Overgrown Hedges on Spellis Green Lane
- Tidy Sling Lane within Parish boundary refer to 4.d of minutes

Land Owner

- Overgrown hedge on paddock, Ladywood – owner established: Chairman to follow up.

Cllr John Brodrick joined the meeting at 7.10pm.

ii. Salwarpe Canal Bridge – Cllr Oakley reported that bore holes were drilled into both sides of the bridge in mid-December and no conclusive evidence was found for the bridge parapet cracking or movement. Further investigations were taking place and repair works to be monitored along with proposed development of Memorial land site. Matter ongoing.

b. Planning and Enforcement

i. Court Farm – Councillors agreed that representations should continue to be made to Wychavon DC regarding the continued neglect to the Listed Model Dairy Building and that previous papers relating to the site would be forwarded to the Heritage Officer. Item carried forward for Chairman/Clerk to follow up.

ii. South Worcestershire Development Plan

The changes that were made as a result of consultation now require a second consultation; there is nothing in the changes which affects the Parishes. The latest consultation is open until 22/02/13.

c. Localism, Neighbourhood Planning, New Homes Bonus

i. New Homes Bonus

The first tranche of the NHB for the restoration of the War Memorial site is now in the Parish Council's bank account.

ii. Memorial Land

The Chairman reported that the first instalment of funds had been received. Wychavon DC had confirmed that no planning consents were required for the repair to the War monument. A site meeting had been carried out with the Tree and Landscape Office, Parish Tree Warden and Contractor and a schedule of work on identified trees were approved.

Several sections of the original iron railings were missing and needed replacing. It was decided that quotes should be obtained for replacing the fencing with wooden fencing and netting as these were less likely to be stolen than iron railings. **Clerk to action.**

iii. Neighbourhood Planning

North Claines Parish Neighbourhood Plan has gone forward and have received confirmation of the relevant finance from Wychavon DC. North Claines Parish Council would be in touch in the near future.

iv. Community purchase of heating oil

A notice was placed in the February Community News magazine informing residents that the Parish Council would consider this scheme alongside forthcoming initiatives from Wychavon DC. **Matter ongoing.**

d. Trees and Footpaths

i. Access through Hindlip

Footpath access between the Drive and Sling Lane - route of Footpath No. 555. Cllr A Miller walked the footpath with the County footpaths officer and found it to be fairly well-maintained. Discussion took place around whether the lane was a byway or was access only; to be resolved. **Chairman to action.**

e. Other

i. Smite Gypsy Site - Pershore Lane

Horses grazing on neighbouring fields and roaming loose on roads was raised as an issue. It was agreed a request would be submitted to West Mercia Constabulary under the Freedom of Information Act to establish how many incidents of loose horses on the road were recorded in the area.

Clerk to action.

ii. Red telephone box at the top of Copcut Lane

BT has confirmed that the telephone box will be removed. **No action.**

iii. West Mercia Police HQ: New lighting

Residents had complained of new lighting installed at West Mercia Police HQ which was causing excessive light pollution to neighbouring properties, all of which are located in the Green Belt. A response from the Enforcement Officer had been circulated referring to planning approval against W/05/00511. It was agreed further investigation would take place. Clerk to action.

v. Court Farm Safety Barriers

The safety barriers currently positioned on the corner of Court Farm, at the junction of Hindlip Lane and Sling Lane were still considered to be a hazard to motorists due to the close proximity to the highway and that they impaired visibility on the corner. **Clerk to report to WCC Highways Team.**

vi. Copcut Elm Pub Fallen Elm

The fallen elm tree in the hedgerow on the left hand side of the A38 travelling southbound opposite to the Copcut Elm pub and just below the Car Sales premises was still reported as being a hazard. Clerk to report to WCC Highways Team.

Clerk Updates:

a. New Homes Bonus

The allocations for the NHB for year 3 had been received from Wychavon DC; no allocation had been received for this year.

The Parish Council could still potentially receive £3,633 each year from the NHB for another 3 years. Councillors were asked to consider potential projects.

Update on Progress of Handover to New Clerk

b. Emails and Planning Applications had been handed over. The finance aspects would be handed over this week. Clerk notified Councillors of her mobile number for use in emergencies.

5. Reports of County & District Councillors

- He had spoken to the Duty Sergeant and Duty Inspector regarding overspill parking issues as a result of Worcester Rugby Club matches; owners of cars parked illegally had been written to.

6. Finance

a. Payments since last Meeting

Payments made and received since the last meeting were reviewed and approved (see Appendix 1).

b. 2013-14 Precept

Elaine Meredith circulated a document explaining the changes to the Council Tax system and how this would affect the precept in future years. It is anticipated that the funding gap for 2013/14 would be met by Wychavon DC.

c. Notice Boards

The clerk reported that the noticeboards, particularly the one at Hindlip needed repair. It was agreed that:

- Hindlip Board: as part of the response to the Woodside Cottages development a new
 noticeboard would be requested and be resited as part of the proposed boundary. In the
 interim period the board will still need to be repaired. Quotes would be needed as the board
 was in need of urgent repair. Clerk to action.
- Newlandhurst board: a new board to be erected as part of the development of the site.
- Copcut noticeboard: a letter would be written to the developer to request a double noticeboard. Chairman to action.
