- 3432 COMMUNITY LEGACY GRANT, APPLICATION FOR CHURCH KITCHEN / TOILET. The Chairman Cllr Mr M Hadley outlined the history, that the church is applying for a grant from WDC to install a toilet and a kitchen in the church and had passed the 1st stage of the application. However, Cllr M Hadley was concerned with the principles of the application as religious groups were excluded from the grant process and the Parish Council would have to complete the application for £15,000 on behalf of the church.

Prior to the council meeting, Cllr Mr M Hadley, Cllr Mr P Langham, and Mrs C Hart (representing the church) attended a zoom meeting organised by WDC to learn more of the application process and the future actions required to proceed with the application.

Mrs Hart explained that two years ago the church decided to install a kitchen and toilet as it was not used just as a place of worship but also a community centre. A management committee had been formed and started the planning process by employing an architect and going out to tender which resulted in an approximate estimate of £30,000. Fundraising has been organised and has already generated funds.

The discussion continued with all councillors having an input into the pros and cons of the application, when this concluded the Chair asked the Councillors to vote on whether the Parish Council should proceed with the application.

The result was a majority vote in favour of proceeding with the application.

Cllr Mr P Langham and Mrs Hart agreed to manage the application, starting with an article in the S&B Chronicle asking for community support, which was required and would contribute to the consultation document which needed to be submitted to WDC by 17th February, following this the completed application must be signed and submitted by 5th March.
