3492 PROGRESS REPORTS

a. Police update and Traffic Calming (3479a and 3482d) – PCSO Aiden Goundry stated that there was nothing to report.

The Clerk reported that he had an in-depth conversation with David Perridge, Road Safety Operations Manager, West Midlands Police (Safer Roads Partnership) about our VAS and its recorded speeds and speeding in general through our village. The clerk also requested that we start the process of applying for the Safer Roads Partnership which would allow residents to manage the monitoring speeds through the village; Mr Perridge asked that this request should be made through PC Joe BROOKS, Droitwich East Safer Neighbourhood Team, West Mercia Police.

Subsequently PC Sam Hughes, Droitwich Speed Watch, contacted the Clerk to find out more information about speeding in the village, she then passed on the PC's details to Mark Whats also from Speed Watch, who will organise the installation of speed monitoring equipment together with physical traffic monitoring in the village over the next two weeks.

- b. Roundhill solar farm and battery storage facility, Worcestershire, on behalf of JBM Solar Projects (UK) Ltd. (3479b) the Clerk had contacted Inkberrow PC (as this land is within their parish) who stated that they have not heard anything and have taken it off their agenda. Cllr Mr M Hadley reported that he had contacted JBM and they confirmed that the application was still active, if it does proceed, the next step would be for JBM to organise a public consultation.
- c. Issues re: Ongoing Disturbance and Planning Application at Upper Priest Bridge Farm, Dark Lane, Bradley Green B96 6SN (3479c) As this is in FPC the Clerk asked the Feckenham Clerk

The Clerk had also written to Simon Jones, Principal Planning Officer at RBC regarding 4 unauthorised residential units and to Mark Lane, Planning Monitoring & Enforcement Officer, WCC to investigate the issue of operating a compositing licence only between the hours of 9.00am to 5.00pm.
