- District Councillor Brian Lewis informed the Parish Council about his recent visits and brought the Council up to date with planning issues and Worcestershire County Council's (WCC) Changing Futures Fund

## 7. Worcestershire County Council Highways

The Clerk gave an update as follows:

- i. The extension of the existing Chaddesley Corbett 30mph speed limit (outside the new school) is currently out to public advertisement. The deadline is 27 December 2012. The proposed 50mph limit between Chaddesley Corbett and Bromsgrove was not supported by WCC Members and will not be progressed. Additional warning signs and road markings have been ordered at the problem areas. The Clerk was instructed to contact County Councillor Sheila Blagg to express the Parish Council's disappointment and to ask why the proposed 50mph limit between Chaddesley Corbett and Bromsgrove was turned down
- ii. WCC have informed the Clerk that the painting of the parking restriction lines in Priory Road and Fockbury Road is programmed for operation on 10 January 2013
- iii. WCC Highways have placed an order for the bollards on the verge outside the Chennai Restaurant and Country Forge, but they are included in a long list of similar works and WCC are unable to give a date for completion
