#### 09/20 Highways & Lengthsman

- Following the persistent heavy rainfalls the lengthsman has been very occupied with ensuring the larger culverts around the Parish are clear of debris particularly on the B4208. A new area of flooding is along Church Road and further investigations are necessary to see if drainage can be improved. Clerk and lengthsman to action.
- Large long hole off highway reported along Cutlers Lane and at bottom of Feathers Pitch, the latter marked for repair by WCC Highways.
- Littler picking by Mr Smallwood acknowledged.
- The matter of toads crossing the road at the top end of Hollybed Street has been addressed at 4C's a number of times. So an initiative by Parish Council has been agreed to prepare signs which will be placed on either side of highway from February to end of March to warn motorists of this seasonal activity. Need to consider any other such areas. COST?
