# MARTLEY PARISH COUNCIL

Minutes of the Annual Meeting of the Parish Council meeting held on Monday May 14<sup>th</sup> 2012 in the Library

Present: Cllr D Goodyear, Cllr M Nott, Cllr G Baxter, Cllr S Cumella, Cllr T Gale, Cllr M Gardner, Cllr R McHugh, Cllr T Studer, Cllr M Walker

- **1.12 Election of Chairman:** Cllr McHugh proposed that Cllr D Goodyear be elected Chairman. This was seconded by Cllr Cumella and was passed unanimously.
- **2.12 Election of Vice Chairman:** Cllr Walker proposed that Cllr Nott be elected as Vice Chairman. This was seconded by Cllr Studer and was passed unanimously.
- **3.12 Apologies:** Apologies were received from County Councillor A Davies.
- **4.12 Declarations of Interest:** There were no declarations.

#### **Democratic Time:**

Discussion took place on housing. Guy Woodissee of Bayhill Properties attended the meeting and set out his proposal for the land by Rogers Coach Yard. The proposal is for 30-40 houses which would deliver a number of affordable houses with a local connection clause. He said that it would take until November to do the technical assessments necessary. Concern was expressed about a possible planning application for developing the "Crown Site". Cllr Williams said that Council should obtain advice from Gary Williams of MHDC to see what the consequences would be if both applications went in together. The Clerk to arrange a meeting with Gary Williams. A housing needs survey is required.

- **6.12 Code of Conduct:** The current code of conduct is being abolished at the end of June. WCALC will be advising on the replacement before July 1<sup>st</sup>.

- 9.12 Representatives on Outside Committees:Old Grammar School Foundation: Cllr Goodyear and Cllr Gale

- **10.12 Minutes:** The minutes of the meetings held on April 2<sup>nd</sup> and 11<sup>th</sup> May were approved and signed accordingly.
- **11.12 District Councillor's Report:** Councillor Williams reported that a Housing Needs Survey is on the MHDC website and that it will be advertised in the Malvern Gazette.

Councillors felt that this method would not capture a true result. She also suggested that the Planning Officers should make a site visit to Berrow Hill in connection with the Planning Application.

- **12.12 Planning:** Application 12/00558/LBC alterations to former card house, Lower Horsham Farm was reviewed and Council fully supported this application.
- **13.12 Alternative Housing Sites:** Cllr Cumella reported that Council needs to formally notify MHDC of it's intention to prepare a Neighbourhood Plan.

### 14.12 Correspondence:

WCC – Footway Enhancement Initiative 2012/13. The Chairman will walk the school footpaths with the Clerk as it is felt that these could be recommended under this initiative.

WCC – Councillors Divisional Fund. It was agreed that Short Mat Bowling be advised of this fund.

MHDC – An introduction to planning. Cllrs Gardner and Studer to attend.

Community First – Village Agents Scheme. Cllr Studer to review

Villager – request for article re individual councillors. Council happy with this proposal.

Email from parishioner concerning rubbish behind Crown. Clerk to write to the brewery.

Call from parishioner concerning rubbish in bins. Cllr Gardner kindly offered to empty bins in future.

#### **15.12 Progress Reports:**

Jubilee Tree Planting: A disease resistant elm tree will be planted in September.

Jubilee Celebrations – progressing well. It was agreed to purchase a banner for the centre of the village.
